 in the form of flowcharts by the <u>Committee on Publication Ethics (COPE)</u>
- Where there are others who have participated in certain substantive aspects of the research project, they should be named in an Acknowledgement section
- Authors take collective responsibility for the work. Each individual author is accountable for ensuring that
 questions related to the accuracy or integrity of any part of the work are appropriately investigated and resolved
